

Exhibit Note—Before Filing:

Though the bulk of my receipts and records were in hard copy format at the house and/or included in my business emails which I no longer have active access to, I wanted to put together some of the receipts I had copies of in my former backup personal account I used after my FFL expired. I'm hoping to be able to retrieve the others from the archived business email files before issuing subpoenas to the wholesalers and distributors for the bulk of purchase order and transfer records.

Though the total of this batch of invoices only **totals \$6,441.06**, it is likely only about **10-15% of the total non-firearm expenditures** (ammo, gear, accessories).
