**PLAINTIFF'S NOTICE OF FILING SUPPLEMENTAL EXHIBIT D13 IN SUPPORT OF
RENEWED MOTION FOR TEMPORARY RESTRAINING ORDER
AND PRELIMINARY INJUNCTION**

Plaintiff, Luke A. Thomas, pro se, hereby files the attached **Supplemental Group
Exhibit D13** in support of his First Amended Complaint (Doc. 33) and Renewed Motion for
Temporary Restraining Order and Preliminary Injunction.

The attached exhibit consists of the following documents:

1. **Mayo Clinic Clinical Note (September 14, 2022):** A true and correct copy of a clinical note documenting a conversation between Mayo Clinic Social Worker Amy Allen and Cass County Sheriff Devron Ohrn.
2. **Discovery Materials from People v. Thomas, Case No. 22-CM-62:** True and correct copies of discovery produced by the State in the above-referenced criminal case, including the Illinois State Police Field Report, the Arrest Warrant, the Emergency Order of Protection, and screen shots of the text messages that formed the basis for the arrest warrant.

RELEVANCE OF THE EXHIBIT

This exhibit is directly relevant to the following claims and arguments:

I. Sheriff Ohrn Made False Statements to Mayo Clinic to Discredit Plaintiff and Interfere with His Medical Care

The Mayo Clinic clinical note (September 14, 2022) documents that Sheriff Ohrn told the Plaintiff's medical providers that Plaintiff had "lost sense of reality" and that Plaintiff was claiming to be "dying from cancer."

The discovery materials from the criminal case conclusively disprove this. The text messages relied upon to obtain the arrest warrant show Plaintiff's actual statements—pleas for food, water, and medicine; efforts to report crimes; and concerns about his children's safety. At no point in any of these messages does Plaintiff claim to be "dying from cancer." Sheriff Ohrn's statement to Mayo Clinic was a deliberate, malicious falsehood designed to discredit Plaintiff to his medical providers and to portray him as mentally unstable. At no time did Plaintiff ever claim to Ohrn or anyone else he was "dying from cancer".¹

¹ After all traditional attempts to report defendants' conduct to the Cass County Sheriff and State's Attorney failed, Plaintiff had no other way to memorialize the events and report Defendants' conduct due to the limited resources—little money, a broken phone, limited clothes and no computer.

II. The Criminal Prosecution Was Baseless and Motivated by Bad Faith—As Conceded by the State's Attorney

As previously documented in Plaintiff's Supplemental Exhibit D11 (filed July 29, 2026), the Cass County State's Attorney conceded a conflict of interest and was disqualified from prosecuting Plaintiff on April 28, 2023. See *People v. Thomas*, Case No. 2022-CM-66, Judici Docket (04/28/2023 entry: "Parties Stipulate to the Defendant's Motion in RE: Conflict. Motion is hereby granted. The Appellate Prosecutor's office is hereby appointed as prosecutor."). The discovery materials now submitted as Exhibit D13 demonstrate precisely why that conflict existed. Plaintiff had reported constitutional violations by Sheriff Ohrn and others to the State's Attorney's Office prior to and during the criminal prosecution. The State's Attorney's Office was simultaneously prosecuting Plaintiff for conduct arising from the very events Plaintiff had reported. The State's Attorney's concession of conflict—and the subsequent dismissal of the charge on January 22, 2024—is a tacit acknowledgment that the prosecution was improper and should not have been brought.

III. Exhibit D13 and Exhibit D11 Together Prove the "Bad Faith" Exception to Younger Abstention

Read together, Exhibits D11 and D13 establish a complete narrative of bad faith:

1. Plaintiff reported crimes committed against him by Sheriff Ohrn and others to the Cass County State's Attorney.
2. Instead of investigating those crimes, the State's Attorney's Office prosecuted Plaintiff for conduct arising from those same events.
3. The State's Attorney conceded the conflict and was disqualified.
4. The prosecution was ultimately dismissed.

This sequence of events demonstrates that the state court system was not a neutral arbiter, but a weapon used to retaliate against Plaintiff for asserting his constitutional rights. The state forum is not merely inadequate—it is actively hostile.

IV. The Exhibit Supports the ADA and Vulnerable Adult Claims

These documents confirm Plaintiff's status as a "vulnerable adult" and demonstrate how Defendants exploited that vulnerability. The text messages are plainly the communications of a desperate and vulnerable individual—not a threat. The decision to prosecute based on these messages is direct evidence of the disability discrimination and retaliation alleged in the First Amended Complaint.

V. The Exhibit Is Incorporated by Reference with Exhibit D11

Pursuant to Federal Rule of Civil Procedure 10(c), Plaintiff incorporates by reference his previously filed Supplemental Exhibit D11 (Doc. 41), which documents the disqualification of the Cass County State's Attorney. Exhibit D13 provides the underlying factual basis for that disqualification, and the two exhibits should be read together as a complete record of the bad-faith criminal prosecution.

CONCLUSION

For the foregoing reasons, Plaintiff respectfully requests that the Court consider the attached Supplemental Exhibit D13 in connection with the First Amended Complaint and the Renewed Motion for Temporary Restraining Order and Preliminary Injunction. The exhibit demonstrates:

1. That Sheriff Ohrn made deliberate false statements to Plaintiff's medical providers.
2. That the criminal prosecution was baseless and motivated by bad faith.
3. That the State's Attorney's conflict of interest (documented in Exhibit D11) was directly related to the events underlying this federal action.

4. That the state forum is not neutral and adequate.
5. That irreparable harm to a vulnerable adult is ongoing.

** Mr. Thomas did not present for today's appointments. Please see his portal message, sent to Jessica Mitchell, CNP from yesterday for further details.

Upon review of Mr. Thomas' portal message there were many concerns for stability of mental health, vulnerable adult, &/or harm to others. As mandated reporter & duty to warn, Social Work attempted to connect with Mr. Thomas both via phone & portal throughout the day. When Mr. Thomas remained unreachable, Social Work reached out to Cass County Law Enforcement to request welfare check.

Social Work spoke at length with Cass County Sheriff - Devron (217.452.7718 / c - 217.370.5225). Explained that purpose of call was to share Mayo Clinic's concerns about Mr. Thomas & family's safety following a quite concerning portal message & lack of presentation today at medical appointments. Understand that area law enforcement & specifically Sheriff Devron are aware of Mr. Thomas' circumstances.

Sheriff Devron shared that over weekend spouse formalized an order-for-protection (OFP) with an area judge. On Monday 9/12/22 this information was shared with Mr. Thomas, whom was then asked & escorted off household premises.

Sheriff Devron is aware that Mr. Thomas left home with a small amount of cash & no weapons, despite awareness that he is avid gun collector. Sheriff Devron explained that over past 48 hours all guns have been removed from Thomas household residence, primarily for minor children safety, but also in event Mr. Thomas attempted to return home.

Sheriff Devron is aware of the various posts Mr. Thomas has made on social media. Sheriff Devron explains that there is gap in mental health care in State of IL, which is hindering their ability to get Mr. Thomas acute care. Sheriff Devron believes Mr. Thomas has "lost sense of reality. He kept saying that he's dying from cancer. Though wife - Gwen explains there is no active cancer."

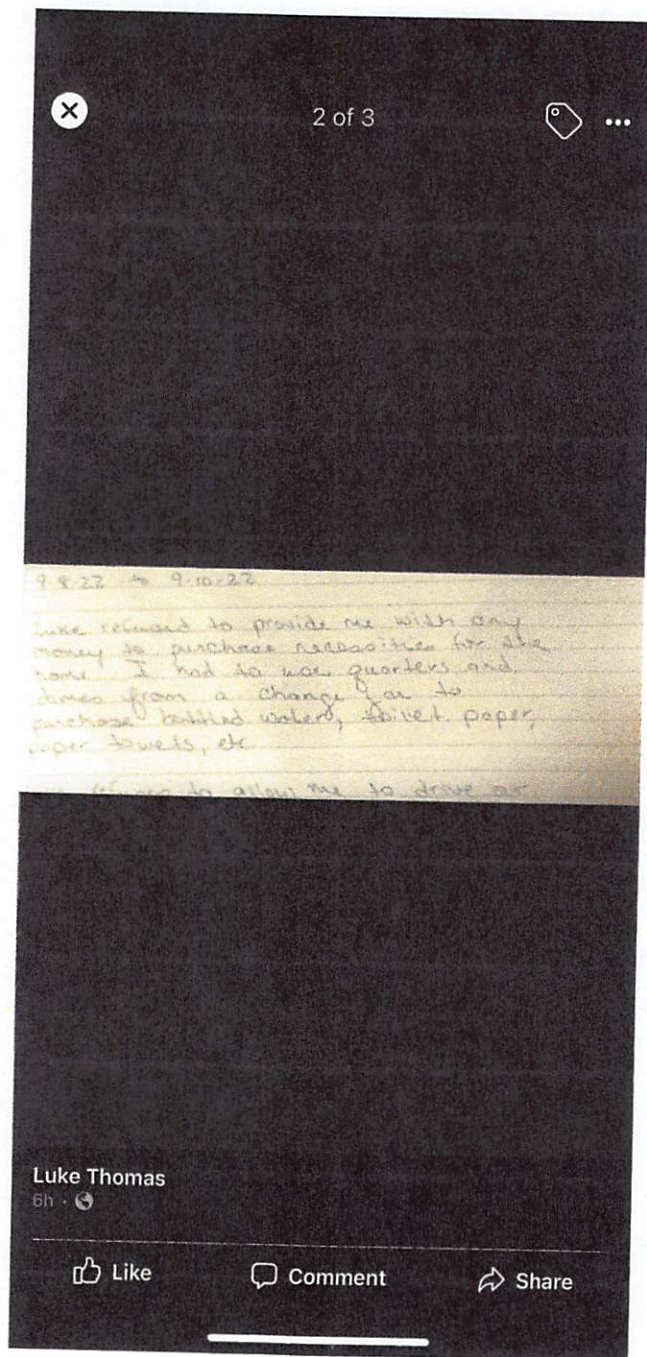
Sheriff Devron was aware that Mr. Thomas had appointments at Mayo Clinic today. Sheriff Devron also knew that Mr. Thomas would not be presenting for a variety of reason, though a primary barrier is family's lack of health insurance coverage.

Sheriff Devron's most recent conversation with Mr. Thomas was around noon today. Sheriff Devron has no insight as to where Mr. Thomas is physically at this time. Sheriff Devron & other local law enforcement have informally searched the county, but have been unsuccessful in identifying Mr. Thomas' location. Sheriff Devron & area local law enforcement (including spouse - Gwen's father, former area sheriff, & Gwen's brother whom is sheriff in a nearby county) continue to search informally as there is personal & professional reasons to help Mr.

Thomas & entire family during this time.

Social Work expressed appreciation for Sheriff Devron's time & collaboration today. Above information was shared with Medical Oncology care provider, Jessica Mitchell, CNP & Social Work clinician supervisor.



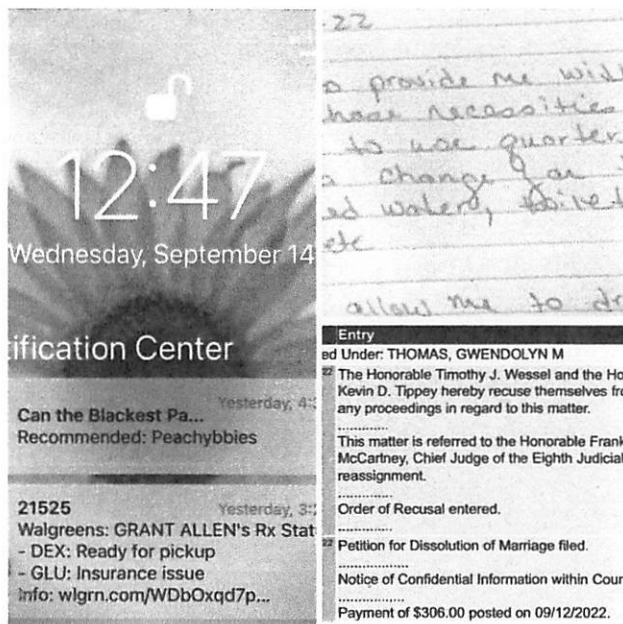
